13 May 1972: Miss Margaret Fisher, Associate Archivist, Department of Archives and Instructor of History, Louisiana State University, Baton Rouge, La., lectured on genealogical materials in the L.S.U. Archives and how to use them. Many items of great interest to our area were discussed and the lecture was followed by a question and answer session.

10 June 1972: Dr. Phillip C. Cook, Professor of History, Louisiana Polytechnic University, Ruston, La., lectured on early sattlers of northwest Louisiana, primarily of Bienville and Claiborne parishes. Dr. Cook is one of those rare historians who are also genealogists, experienced and skilled in both fields. He is now completing a book on early families of Bienville and Claiborne Parish to be published this fall. We are eagerly looking forward to its release.

#### WHAT OTHERS ARE DOING

#### NORTH LOUISIANA HISTORICAL PRESERVATION CONFERENCE

The first North Louisiana Historical Preservation Conference was held 24 June 1972 at LSU in Shreveport, La., sponsored by the North Louisiana Historical Association and Louisiana State University in Shreveport. Mr. Tom Ruffin, Pres. North Louisiana Historical Association, called the conference to order at 9:00 a.m. The welcome was by Dr. Donald Shipp, Dean, LSU in Shrevport, and by Mr. George A. Burton, Commissioner of Finance, Shreveport, La. Over 200 attended this conference to hear lectures by Mr. Jared W. Bradley, Director, Louisiana Historical Commission, and by Mr. J. Reid Williamson, Jr., Executive Vice-Pres. Historic Savannah Foundation, followed by a Question and Answer period. After lunch and a tour of the Historical Exhibits in LSU-S Library, there was a panel discussion conducted by Mr. Dewey Somdal, Mr. Bradley and Mr. Williamson, followed by two separate workshops. The Social Hour beginning 5:00 p.m. at the Symphony House in Shreveport concluded the all-day conference.

This is another big step forward in the preservation of our history and our heritage. It will add much to the future of Northwest Louisiana as a cultural center and will only enhance its rapidly growing fame as a genealogical-historical research center for anyone interested in records of our area.

## GENEALOGY AND LAND TITLES

Genealogy is defined as an account or history of the descent of a person, family, or group from an ancestor.

An Abstract of Title is defined as a summary of the successive conveyances and other facts upon which a person's title to a piece of land rests.

An expert genealogist might also be classified as an expert title abstractor. A title abstract deals with "land titles" -- a genealogist with "people" titles.

Although the account or history of the descent of a person need not be associated with land titles, certainly such records are of vital importance in tracing America's early pioneers.

What would a genealogist determine from land titles? First and foremost, it is very often only known that one's ancestors immigrated to America in the latter part of the 18th century or the early part of the 19th century. Where? When? To what part of the present United States did he choose to immigrate?

Let us assume that he chose that promising region in the vicinity of the Mississippi River. Not knowing the exact location of his choice of settlement, one could perhaps check census records; but perhaps an easier method would be to make use of volumes of records found in the office of Ellen Bryan Moore, Register of the State Land Office, (in Baton Rouge, La.)

In order to determine what records are available in the Land Office and what information they would provide, let me review chronologically records which are accessible to you.

# Land Grants (Exhibit "A")

The practice of granding tracts of land to encourage formation of colonies apparently led many from Europe to move to the land of the free - America. We find that in what is now the State of Louisiana, many hundreds of land grants were given by the governments of France, England and Spain.

A typical grant would have been normally along a navigable stream due to absence of roads as well as the hazards of overland trails. Almost all land grants were surveyed utilizing natural markings, neighbors or secondary streams to pin-point location. Very often a neighbor would have been a close relative as often brothers secured adjoining land grants.

## Louisiana Purchase (Exhibit "C")

The consumation of the Louisiana Purchase on April 30, 1803, meant the addition of some 544 millions of acres to the fledgling United States. A provision of the Louisiana Purchase was that recognition would be given to valid land grants.

#### Land Districts (Exhibit "D")

Very shortly after the Louisiana Purchase, by Act of March 26, 1804, Congress divided the new property acquired into two areas: The Territory of Louisiana and the Territory of Orleans. The Territory of Louisiana covered the area lying above the 33rd degree faticude; whereas the Territory of Orleans covered that part of the Louisiana Purchase lying below the 33rd degree latitude, or what is now basically the State of Louisiana.

An act of Congress of March 2, 1805, stipulated that the President of the United States could designate district land offices in the newly created Territory of Orleans. A Register and Recorder for each district was to be appointed by the President. Initially an Eastern Division, with an office in New Orleans, and a Western District, with an office in Opelousas, were created; however, eventually there were five District Land Offices: Southwestern in Opelousas; Southeastern (New Orleans); North of Red River (Monroe); Northwestern (Natchitoches; and Greensburg (Greensburg).

## Board of Commissioners

The same act of Congress of March 2, 1805, also authorized the President of the United States to appoint a Board of Commissioners whose duties were to review proof of any inhabitant claiming a land grant. Those inhabitants had to appear before the Board with witnesses and affidavits to certify that the grant they held was valid and bonafide. If the Board of Commissioners certified that the grant was fully legal, it was then approved by the Board and this approval forwarded to the nation's capitol in Washington.

Now let us consider why land grant titles and records relating thereto are of interest to you as a genealogist.

First, the appearance of an individual before a Board not only gave the name but the year that person was in a specific area. The witnesses, who accompanied the holder of a land grant, were often relatives or neighbors which also gave important information. Signatures which appear on the many thousands of affidavits are original and often the proof that this is the ancestor you are looking for.

In addition to serving on the Board of Land Commissioners, the United States District land registers were authorized by law to sell lands to individuals these sales gave the name, a definite date, location, and often authentic signatures; so again you could pin-point where and when in the Territory of Orleans and in the West Florida Parishes (Greensburg Land District) that specific ancestor had settled. Needless to say, once such a determination has been made, the courthouse of the parish wherein that individual resided can then furnish a wealth of inforamtion such as births, marriages, death certificates, mortgages, easements, judgements, as well as additional land acquisitions.

# Meridians (Exhibit "F")

We speak of land sales -- A system of subdividing land into sections and townships was devised by Thomas Jefferson in 1785, adopted by Congress in 1805, and used by Congress i: Surveying the Territory of Orleans.

We find that by 1807, United States surveyors had established a <u>principal meridian</u> and a <u>base line</u>. The base line was relatively easy because the surveyors extended westwardly a previously surveyed line setting the southern boundary of the Territory of Mississippi between Mississippi and Spanish Western Florida. The pricipal meridan running north and south from the base line was established approximately in the center of the territory.

This system initiated the method of laying out a square six miles high and six miles wide and re-subdividing this square into 36 square miles or sections. Each section comprizes 640 acres. Sections are numbered 1 to 36 beginning at the top row in the northeastern corner and running east to west; thence the next row west to east, etc. Acts of Congress of April 21, 1806 and February 15, 1811 reserved the 16th sections for the support of schools.

#### Townships

Not all townships were composed of 36 sections. Instructions given to surveyors were that when they came upon a navigable stream in areas where land was in demand, they were to use narrow radiating lots on the water courses of approximately 8 arpents frontage and 40 arpents deep. This enabled more individuals to obtain water-frontage tracts and meant more spirited land sales by the Federal Government.

## Official Township Plat

Instructions were further given federal surveyors that in each township they were to, first of all, plat all affirmed private land grants, then the remaining lands as public lands could be disposed of by appropriate laws.

The early land surveyors came from an office in Tennessee; however, in 1831 a United States Surveyor General's Office was opened in Donaldsonville. That office was eventually removed to New Orleans. In 1909 this office closed and all of their surveys, plats, field notes, and correspondence were given to the Land Office. (Louisiana State Land Office in Baton Rouge, Louisiana)

The United States District Land Offices were later consolidated into one office and in 1921 that office closed and all their records, correspondence, affidavits, copies of land grants, and other documents were turned over the the State Land Office.

So you see, of interest to you in the Land Office are thousands of early colonial land transactions in Spanish, French, and English (British).

We are indeed fortunate those records were transferred to the Louisiana State Land Office; otherwise many of you interested in land title research for genealogical purposes would probably have to go to the United States Land Office in Washington for that same information we have readily available in Baton Rouge.

The American State Papers, available in the Land Office, list alphabetically the names of individuals who applied for approval of a land grant. These papers state whether grants were approved or disapproved by the Board of Commissioners, the desired location, as well as the date of application.

Of interest in discussing land sales and patents is the fact the the first Constitution of Louisiana in 1812 provided that in order for an individual to vote, he had to be a free white male, 21 years of age, and had to have purchased land from the United States Government. Records on file in the Land Office reveal that in order to vote often 50, or as many as 80, individuals would group together to buy a 10 acre tract of land. These were individuals who may not have had much wealth or were fairly new arrivals in Louisiana, but still of extreme importance as they were someone's ancestors. The next Constitutional Revision in 1848 eliminated the need of having pruchased land in order to vote.

We in the Land Office are doing our best to gear our records to suit you and to make your job of researching names easier. We are indexing by names and binding in books all letters and affidavits. All irreplaceable valuable historical records have been laminated for assurance of endurance, as well as usage and study, by many, many more generations.

Those of us who deal in land titles recognize what genealogists are doing in awakening people to appreciate and realize the importance of historical records. We are grateful to the many organizations and groups who have taken upon themselves the goal of preservation of our heritage.

We might ask if any of you, in doing genealogical work outside the State of Louisiana, find records pertaining to early Louisiana settlers, and such records are not available in Louisiana, then perhaps the State Department of Archives, the State Library, or the State Land Office would acquire copies. Such copies would then be available in Louisiana for ready reference. The value of having historical records in our possession for ready reference can not be over-emphasized.

It is good to know Louisiana is now awakening in its effort to preserve its heritage. The efforts of Louisiana's Genealogical Societies stand our in the forefront in this endeavor, and we commend you most highly for your interest and your many programs.

Editor's Comment

Indexing of the U. S. Tract Book Records for Louisiana has probably been completed by this time. If your ancestor purchased land from the U. S. Government, you should write to Office of Register, Louisiana State Land Office, Baton Rouge, LA 70804. If you know the approximate location you should state the area in which your ancestor settled - check the following charts to determine possible District Land Office who handled the sale. Photo copies of the records are available at reasonable cost, but will only show the exact location of the land, date of purchase, certificate number, and purchaser's signature - or if a bounty land warrant, etc. The records do not show age, birth place, parents or other genealogical data, but at least, you will have that particular ancestor located in some specific place at some specific time.

These records show only lands disposed of by approval of grants, or by sales by the U. S. Government, and later by the government of the State of Louisiana. No records of later sales or transactions pertaining to the land will be found in this office. For later records you will need to go to the courthouse of the parish where the land is located.

We have worked in U. S. Tract Book Records in Louisiana, Alabama and Georgia. Alabama Tract Books are located in the office of the Secretary of State, in the State Capitol, Montgomery Alabama. Early Georgia land records are located in the Surveyor General's Office in the State Archives Building, Atlanta, Ga.

In your research, never neglect to check early land records for any area you may be interested in. They show who were the neighbors and relatives of your ancestors living in the same areas - and will give you many new clues to follow on other branches of your family.

Deed Books, Mortagage Books, and other land records have been indexed in most courthouses. When you are checking for other records, take time to check the indexes to all land records. A man frequently neglected to have his marriage recorded, but he <u>never</u> failed to have his land recorded, even if he had to swim the creek to reach the courthouse.

Whether Federal, State or County Land Records, these can be just as important as marriage records, wills and other data in your research, and often much easier to find.







HOME COMING Plain Dealing, Louisiana July 9, 1972

Mr. Orlon Dodson, Channel 3, KTBS-TV, Shreveport, La. supplied the program for Home Coming at Salem Baptist Church, held July 9, 1972 in Plain Dealing, La. and the following additional information: Dated July 9, 1977.

"Today was homecoming at the oldest Church in Bossier Parish -- The Salem Baptist Church of Plain Dealing which was organized in 1844. The day's activities included a lunch which was served at the Seminary Building. The Church now has a membership of 97 but that number was increased today by the visitors present for the special occasion. After the lunch and a break for some leisure activity, there was an old-fashioned singing in the Church. The congregation joined in as the Carver and Kimball Families led the program.

The first Church burned in 1860 and another Church was built on that original site and stood until 1878 when the Church was moved from the Salem Cemetery location to the present Redland side. Although the building has been remodeled, it is still basically the same structure which now about 93 years old.

Several slaves belonged to the early Church and are now buried in the old Salem Cemetery and these films (shown on the TV broadcast) show their graves those of Uncle Fed and Aunt Martha, as they were known.

There was also a cake-cutting ceremony today, even though the Church's official birthday is not until November, when it will be 128 years old. Weilding the knife at today's ceremony was the pastor of Salem Church, Shannon O'Glee and Church elder, D. I. Barnett."

This book contains genealogical data on every family descended from Mary Good which includes about 300 families, with over 1200 names in the index. Related lines are Brees, Cox, Huitt, Howard, McAvoy, Parson, Patterson, Russell and Slack. Records cover from 1849 to 1967.

BIOGRAPHY OF THE GUYERS. Order from Mrs. Goldianne (Guyer) Thompson, 2351 East Iowa, Denver, Colo. 80210, \$10.00. Well documented with history, family trees, wills, marriage and cemetery records and documents of many types; a list of added information in back of book to help anyone working on these lines, plus reference to data in Library of Congress and elsewhere. The Guyer history begins with the French Hugenot family in South France in the 800's and traces them thru Switzerland co Jacob Guyer who mettled in Pennsylvania. There were seven brothers in the family, with a chapter on each family group, and on their descendants. A most interesting, easily read family history told in narrative form.

The Harris Papers, each volume a genealogical notebook, contains abstracts of deeds, wills, court records, etc. of colonial times in North Carolina and Virginia. Counties are - N.C.:Anson, Montgomery, Chatham, Cabarrus, Bute, Granville, Mecklenburg and others; Va. counties are Cumberland, Powhatan, Hanover, Lunenburg, Albemarle, Mecklenburg, et al., for a total of 35 colonial counties of North Carolina and Virginia. Each volume is limited to one county and closely adjacent areas.

There were three Keahey brothers in Richmond Co. N.C. by 1790 and this book is the history of the descendants of James Keahey who was born in Ireland in 1749. The index includes over 10,000 names, and records cover a period of over 300 years.

We were so delighted with them that they were reviewed in a special program at one of our meetings, and we are having them rebound in harback library bindings to protect them from the constant use they will have to endure. The last book, The Descendants of William Milhous, Jr. and Martha Vickers is of the 2nd gr.grandparents of President Richard Milhous Nixon, published in 1971, and contains charming postage/size colored photos of many members of this family, including that of President Nixon. Descendants of these five couples include many names, with carefully documented records. We will attempt no review of these books, but recommend them to all our members and readers, and especially to libraries and archives throughout America.

THE MUDD FAMILY OF THE UNITED STATES, SECOND EDITION IN TWO VOLUMES. Order from Dr. Richard D. Mudd, 1001 Hoyt Ave., Saginaw, Mich, 48607, \$24.00 p.p., special price to libraries - \$19.00 postpaid. The first edition of this book required 22 years of research. This revised edition in two volumes required 19 years to complete the 904 pages in one volume and 936 in the second, for a total of 1840 pages. These two volumes are 8-3/4 x 92", hardback, indexed, illustrated, and every detail meticulously documented. Records include many families, some back to the early 1500's, and most of them brought down to the present generation. Dr. Samuel A. Mudd was awakened the morning of April 15, 1865 by a man with a broken leg. The man was John Wilkes Booth who had shot President Abraham Lincoln. By setting the leg of a stranger who had come to him for medical attention, Dr. Mudd lost freedom, home and honor, although he was only carrying out his obligations as a physcian. The author of the Mudd Family History, both the first and second editions, is a grandson of this Dr. Samuel Mudd, who first set out some 40 years ago to vindicate his grandfather, and eventually became an expert genealogist and historian, plus a well known lecturer on Civil War History. Dr. Richard D. Mudd is also a retired U. S. Air Force Flight Surgeon.

DESCENDANTS OF MATTISON NATIONS AND CYNTHIA GARRETT. Order from Loye E. Nations, 110 Edgefield St., Columbia, S.C. 29201, \$7.50 postpaid. Gives detailed listing of South Carolina branch of the family and lists numerous Nations who traveled from Virginia, North Carolina, South Carolina, into Georgia, Alabama, Tennessee, etc. between 1785-1850. Also contained are a list of Confederate War service by states, real estate transfers, marriages, wills and other records. Completely indexed, 176 pages, softbinding.

NEER KINDRED. Order from Mr. & Mrs. J. R. Gammon, Rt. 2, Box 201, Odessa, Mo. 64706, \$4.50 postpaid. This family history begins with the immigrant, Conrad Neer, born 1710, and his wife Nancy, includes their four children: Phillip, Henry, John and Conrad with collateral lines and is continued down to the ninth generation on some lines. The book has 200 pages, 8½x11", spiral glazed binding, is illustrated, documented, and has an index of 2,300 names.

THE BENJAMIN NICKEL FAMILY, 1810-1970, Pennsylvania, Ohio & Nebraska. Order from Phyllis Ferrara, Rt. 1, Box 365, Forest Grove, Ore. 97116, \$5.00 postpaid. Benjamin Nickel, born 1810 in Pa. (parents unknown) married Julia McCorkle, - cont'd-

daughter of John and Susannah Powell McCorkle, in 1833 in McVeytown, Mifflin Co. Pa., and their first two children were born there. In 1836 they moved to Mercer Co. Ohio where the other eight children were born. Benjamin Nickel enlisted in the 71st Ohio Volunteer Regiment in 1861, at age 51, and died in Clarksville, Tenn. in May 1962 after the Battle of Shiloh. The book tells of each of his ten children and their families. It is well documented after 33 years of research, illustrated with 50 pictures, many of them from tintypes, 80 pages, hardback. Mrs. Ferrara writes that she is continuing her search for Benjamin Nickel's parents. It is known he had three brothers: Samuel, Thomas and James, and a sister Sarah who married a Rien (or Ryan), but little else is known of them. This two-part book begins with James and Catharine Nellis Parshall; Lists ancestors of James back to 956 A.D., and give many of Catharine Nellis's ancestors. The Parshall family came to America about 1820 and the Nellis and Garlock families arrived in 1710. Part two is of the life of James (1815-1898) and Catharine (1823-1907) and their descendants. They had 10 children, and 600 descendants are included in this documented, il ustrated and well indexed book of 400 pages,  $7-3/4 \times 10-3/4''$ , with embossed fabricoid cover over a hardback. Mr. Parshall asks that when ordering this book, please refer to the ad or book review in The Genie so he may evaluate the publicity.

The chapter on the Maddox families opens in Charles Co., Maryland in the 1700's, follows them through South Carolina, Georgia, Alabama, Oklahoma, Louisiana, Arkansas and then to Texas. The index contains over 1300 names with many surnames of allied lines; Many old pictures, maps and numerous documents add much to this family history.

The unusual format includes a good table of contents, explanation of the numbering system used, and a two page list of allied lines, followed by 382 Family Groups, for which it employs Everton's popular No. A-1 family group sheet. Edward, born in England 25 Sep 1634, son of William and Rebecca Tryon, came to Stamford, Conn., married Sarah ? and had one daughter. His younger brother William, born ac 1645 at Bilbury, England, came to America and settled in Wethersfield, Conn. He married 1st in England where his wife died leaving two sons. He married 2nd in Connecticut, Mary Steele, and had eight children, then Mary died. Then William married a young widow Sarah Saint (Latimer) Robinson and had one son. William died 2 Oct 1711 at age 66 and Sarah died 7 Dec 1711 at age 65. The Tryon Family in America traces the descendants of William down to the present generation and contains the names of over 800 Tryons with a biographical sketch on each one. We realize none of these reviews are adequate but we have tried to point out the basic data in each book and to present it to our readers for their information on all the books they may need.

As Editor of The Genie and an often frustrated genealogist, we offer this advice on all these fine books:

Never judge a book by it's cover, price, or brief review. All these books required many years of dedicated and expensive research to collect the records they contain. If any book appears to have information on your family or area of research, order it at once. You can save yourself years of lost time in retracing the paths followed by these authors, and for many of you it could mean the only clue you will ever find on some lost ancestor. As one who descends from at least 100 uncooperative ancestors who play a childish game of "hide and seek" with me, my only hope is to find them in some book. This is a rather new area of research for me, but it has been quite successful many times on some of my most humble obscure ancestors. Don't insist on being a "do-it-yourselfer" all the time - buy a book and take advantage of what someone else has already obne for you. Read every ad and book review in The Genie - and other publications and catalogs, then buy the books you think can help you. Several years ago I had the thrill of finding my gr.gr.gr.grandfather Carr's biographical sketch on the last page of a little book I had ordered in pure desparation, and have been equally successful with several others in other books. Books can be one of your most important areas of research - don't neglect them.
